### **Instructions to the candidates before conducting defending Viva Voce**

#### **Details to be submitted on the day of Viva Voce:**

1. Covering letter from the Supervisor for having carried out all the corrections suggested by Indian / Foreign Examiner in the Thesis.
2. Viva Voce Examination fee as DD for Rs.10,000/- (Rupees Ten Thousand Only) in favor of Sathyabama Institute of Science & technology payable at Chennai.

#### **Details to be submitted after defending Viva Voce :**

1. Xerox copy of the front page of Thesis (A4 size) should be signed by the Supervisor and candidate.
2. Three copies of A5, typed on both sides (All copies to be hard bound)  
(Side sticker should be pasted in all the thesis)
3. In all the copies of A5 thesis the following should be enclosed immediately after the cover page.
  - a. Official letter duly signed by supervisor for having carried out the corrections suggested by Indian/Foreign Examiner/Foreign Examiner Nominee
  - b. Copy of the Proceedings of the Ph.D Viva Voce Examination
  - c. Ph.D Viva Voce notification
4. In two copies of A5 Thesis, the following should be enclosed at the back of thesis following the Curriculum Vitae.  
Indian & Foreign Examiner reports along with the answers to the questions posed should be enclosed.

#### **The format should be**

- After the Curriculum Vitae first keep the Indian Examiner report followed by the details (Name of the candidate, Title of the Thesis, Name of the Indian Examiner their designation and address). Followed by answers to their queries.
  - Next keep the Foreign Examiner report followed by the details (Name of the candidate, Title of the Thesis, Name of the Foreign Examiner their designation and address). Followed by answers to their queries.
  - In case of Rejected / Resend Thesis, the candidate should also enclose the rejected or resend examiners report at the last along with the answers to their queries.
5. Form 11 & Form 12 to be submitted.
  6. Soft copy of the Thesis and a copy of Abstract as PDF in CD with all the above enclosures mentioned (CD should contain one PDF starting from the Title page, letter from the Supervisor, Minutes of the Meeting (duly signed by the members) till the examiner's report).
