The Director Research placed on record that 52 candidates have completed their Ph.D. after the virtual convocation that was held in September 2020. All the other research activities like Ph.D. screening and course work exams were conducted online with the help of LMS. Citing the minutes of the Board of Research, the Director Research requested the approval of the Board of Management for permitting a candidate with Bachelor's degree in Engineering for pursuing Ph.D., as the candidate had 10 years of R&D experience in National Research Laboratories/ Public sector undertakings with publications in refereed journals in the last

Responding to this, Dr.Pattnaik advised that an Equivalence committee be constituted which would evaluate and certify the candidature. Adding to this, Dr. Sanjay recommended that the Dean be the Chair with an Academic council member in the Equivalence committee. Also Dr. Sanjay insisted on the inclusion of a retired Vice Chancellor which would help in taking pragmatic decisions. The Director Research also tabled another candidates issue who had submitted the synopsis but delayed the process

of thesis submission due to family reasons. As it has been 13 years now, the Director Research wanted the board to ratify and take a decision on the candidature. Advising on this, Dr. Sanjay recollected an analogy wherein the candidate was permitted after validating the work. The competence and genuineness of the candidate maybe established after which he/she be permitted to submit the thesis. Further, Dr. Pattnaik referred to the condonement of the Vice Chancellor which can be applied in this context. Also it was recommended that a golden chance declaration be introduced to the guidelines.

Hearing to the recommendations of the BOM, the member Dr.Alagar, suggested that if a candidate is taking a huge delay in submission of thesis, a final chance can be given to submit and present the work to an Expert Committee and get the recommendations, provided the candidate has the bonafide thesis completed in all aspects.

Dr.Mathirajan suggested, to allow the students to submit a draft thesis, directly to the Director (Research) of the University by paying the dues (that is all the fees for the periods). After the submission, his/her thesis should be reviewed by the set of experts, who are formed by the Director (Research). Once the experts accepted the draft thesis based on their assessment, then the Director (Research) could forward the thesis to the potential examiners for the formal evaluation. This suggestion was given based the procedure at IISc and IITs.

Further for Case 1, forming equivalence committee will lead to subjectivity. Dr.Mathirajan, suggested to consider Bachelor's degree and R&D experience candidates for external PhD program subject to allowing them to credit more number of courses comparing with Master's degree and R&D experience candidates. The procedure at IISc and IITs are given as analogy for allowing Bachelor's degree and R&D experience candidates for external PhD programme. It is also suggested to make a resolution in this regard.

For external registrant, the candidate is not necessary to qualify GATE exam. His/her academic qualification with minimum number of R&D industry experience is sufficient to register for PhD programme.

Also during the course of Ph.D programme he has to satisfy 18 credits (8 Courses) for completion of course work.

4 weeks course with weekly assignments and one proctored exam - 1 credit

8 weeks course with weekly assignments and one proctored exam – 2 credits

12 weeks course with weekly assignments and one proctored exam – 3 credits

Whereas coursera and udemy conducts 15 hours of class with assignments and quiz and no credits assigned.

Hence, it is recommended to consider only NPTEL and Swayam for Ph.D requirement to avoid dilution. These coursera and udemy can be undergone by the individual for his professional career.

Dr.Mathirajan suggested Since already there is a huge delay, it was suggested to explore the approach of sending the thesis to the THIRD examiner with the current version of the thesis (subject to both scholar and the Guide strongly feel that the report received from the examiner is not acceptable and that could be one of the reasons for the scholar's delay in his/her responds to the examiner's report). If we accept this

Giving 3 months' time and facing the situation of examiner saying no to re-evaluate the thesis due to huge delay would un-necessarily create a new issue!!

Please note that whatever the situation, if we go to the third examiner, we should not send the evaluation reports along with the thesis for evaluation.

Decision Taken:

Hence it is decided to give a deadline of 3 months time to submit the corrected thesis. If not submitted, then to proceed for cancellation of registration. The corrected thesis will be sent to the third examiner.

If the research carried out in M.Phil and Ph.D are same then coursework exemption can be given for only 2 courses. If not they have to register for 4 courses only.

Duration is to be decided only on case to case basis based on reputed publications in journals.

BOR 19.2

Case 1: Decision for admission to Ph.D Programme with Bachelor's degree and R&D experience.

it was suggested to consider Bachelor's degree and R&D experience candidates for external PhD program subject to allowing them to credit more number pf courses comparing with Master's degree and R&D experience candidates. The procedure at IISc and IITs are given as analogy for allowing Bachelor's degree and R&D experience candidates for external PhD programme. It is also suggested to make a resolution in this regard.

For external registrant, the candidate is not necessary to qualify GATE exam. His/her academic qualification with minimum number of R&D industry experience is sufficient to register for PhD programme.

Case 2:

It was suggested to allow the students to submit a draft thesis, directly to the Director (Research) of the University by paying the dues (that is all the fees for the periods). After the submission, his/her thesis should be reviewed by the set of experts, who are formed by the Director (Research). Once the experts accepted the draft thesis based on their assessment, then the Director (Research) could forward the thesis to the potential examiners for the formal evaluation. This suggestion was given based the procedure at IISc and IITs.

BOR 19.7

Since already there is a huge delay, it was suggested to explore the approach of sending the thesis to the THIRD examiner with the current version of the thesis (subject to both scholar and the Guide strongly feel that the report eceived from the examiner is not acceptable and that could be one of the reasons for the scholar's delay in his/her responds to the examiner's report). If we accept this approach, at the time of reporting the examiners' reports for recommending the degree, all the reports (including the one who deferred the recommendation) should be reported.

Giving 3 months' time and facing the situation of examiner saying no to re-evaluate the thesis due to huge delay would un-necessarily create a new issue!!

Please note that whatever the situation, if we go to the third examiner, we should not send the evaluation reports along with the thesis for evaluation.

The above is only to bring to your attention. If all are agreeing the minutes circulated by you as it is, I will also go with that.
