The Vice Chancellor greeted everyone and thanked the members of the board for their continuous support which enables to improve the quality of research. She also insisted that this meeting will primarily focus on the Ph.D Regulations 2022. She informed about the Research promotion policy, Ethics for research adopted in the University and opened the floor for discussion on various points of the agenda. Director (Research) introduced the new member Dr.Ramesh kumar, Head, Dept. of Biotechnology and then presented the report on the academic research activities for the last six months time period.

Academic Research activities for the period November 2021 – March 2022

Ph.D Admissions

For the session January 2022, as per UGC guidelines on Examination (D.O.No F.1-1/2020 (Secy),dated 29th April 2020), considering the situation of COVID-19 pandemic, the selection for Ph.D Admission for January 2022 was based on Online Entrance Examination followed by Virtual Screening Presentation which was held on **12th and 13th November, 2021** respectively. **11 candidates** have registered under Full-Time mode, and **66 Candidates** have registered under Part-Time mode.

Supervisor Recognition:

23 Faculty have been recognized as supervisors for the period **January to June 2022**. **5** from Faculty of Computer Science and Engineering, **4** from Faculty of Electrical Engineering, **1** from Faculty of Mechanical Engineering, **1** from Faculty of Chemical Engineering, **4** from Faculty of Science(Mathematics), **5** from Faculty of Science(Life Sciences), **3** from Faculty of Science(Physics).

Defending Viva Voce Examination

For the academic year **2021 – 2022**, from 1st November 2021 to till date, 58 candidates have completed the defending Viva Voce successfully. Indian and Foreign Examiners reports have been received for 31 Candidates and are yet to conduct Viva Voce.

1. UGC (Minimum standards and Procedures for Award of Ph.D degree) Regulations 2022

– For Discussion and approval

Eligibility

Dr. Alagar suggested to proceed with the norms as suggested by UGC.

Dr. Mathirajan commented that a candidate who seek admission after a 4 year/ 8 Semesters bachelor degree with research should satisfy the following criterion.

- He/She should be working in the same research organization for a minimum of 3 years.
- He/She should undergo rigorous interview process during admission.
- He/She should not resign the organization till the award of Ph.D degree.
- He/She should identify a Co-supervisor from the same organization.

Dr. Velayudham suggested to consider the publications given by the applicant in a referred journal also some additional subjects to be given with increased credits.

Dr. Mukesh Doble suggested (over mail) the following

- He/She should be working in the same research organization for a minimum of 3 years, carrying out research and not working in admin/sales/purchase/management.
- The Organization should issue a letter stating that who would be the Co-Supervisor from the organization and that the time off given to his to carry out his research.
- A minimum of 3 years for full time and 4 years for part time is to be maintained.

Finally it was decided to consider it as a case by case approach and to get approval from BOR members.

Ph.D Programme and Place of Research

Sathyabama Institute of Science and Technology offers full time Ph.D programme for a minimum period of 3 years and part time for a minimum period of 4 years.

Dr. Alagar suggested to reduce to 2 years for full time for Engineering and 3 years for Science.

Dr. Mathirajan questioned about the rationale followed for the suggestion given by Dr. Alagar.

Dr. R. Govindaraj added to his comments that Engineering graduates spend 4 years of UG and 2 years of PG, whereas Science graduates spend 3 years of UG and 2 years of PG, and hence the variation in the duration of Ph.D programme.

It is decided by all the members that uniformity is to be followed but a provision can be given that under extraordinary circumstances with the recommendations of the board, a relaxation can be given in the time period.

Procedure for Admission

Dr.Alagar and Dr.Govindaraj suggested to proceed with the norms as suggested by UGC.

Dr.Alagar asked to give weightage for experience, publication of articles, research competency during interview process.

Dr.Mathirajan advised to give bifurcation while conducting interview but not to explicitly define the process. Allocation of Research Supervisor, Recognition of Research Supervisor, Allotment of number of candidates to a supervisor, Duration of the Ph.D. program, Extension of time from the maximum duration follows the same regulations as of 2018.

Course Work:Credit Requirements and Comprehensive Examination

It was decided that as per the norms, a candidate with PG degree have to satisfy minimum of 12 credits and a candidate with UG degree should satisfy minimum of 16 credits.

Confirmation of Provisional Registration, Research Advisory / Doctoral Committee, Cancellation of registration, Submission of Synopsis, The Act of Plagiarism, Submission of Thesis, Thesis Evaluation, Oral examination, Issuing A Provisional Certificate, Award of Ph.D. Degree, Depository With Infilbnet/Institutional E-Archive, Publication of Thesis, Power to Modify follows the same regulations as of 2018.

Code and Conduct of Ethics

A draft of the Policy document adopted for ethics and research has been put to Board of Research members for approval.

Dr.Alagar suggested that based on the nature of crime one have the right to appeal directly to law enforcing authority.

Dr.Mathirajan suggested that it can be initially discussed with head of the department in consultation with research supervisor and then to director research . A Committee can be formed and can be appealed to Vice Chancellor.

Finally it is decided to modify based on the suggestions given and also to get the approval from legal advisor of the University.

3. Timeline for Thesis submission beyond the dead line.

As per the regulations, a candidate should submit the thesis within a time period of 3 months after the completion of Synopsis meeting. Under extraordinary circumstances they are permitted to a maximum period of six months. But there are candidates who have completed the synopsis meeting and have not submitted the thesis beyond 1 ½ years - for further action – **For Discussion**

5. Re-registration for Candidates who have exceeded the maximum time period beyond extension.

Applicable to candidates who have exceeded the maximum time period of 6 – 8 years, by neither completing the publication norms nor submission of Synopsis/Thesis.

- To Re-register for the course.
- Conduct of DC meeting with same Supervisor and DC members constituted with one existing member and another as a new member.
- Redefining of the objectives and with a maximum time period of 2 years the candidate should complete the work and publish the new findings in a reputed journal. Then to proceed for synopsis/thesis submission.

Board of Research members approved the above procedure to be followed on a case to case basis.

4. Publication in Science Citation Indexed (SCI) journal – Viscom, English, Management

Candidate should publish their research work in Journals and in Conference proceedings as per the norms of the University during the course of Ph.D programme to fulfill the eligibility criteria for conduct of synopsis meeting.

For Faculty of Humanities (English, Viscom) and for Faculty of Management, the candidates experience difficulty to publish papers in SCI journals – **For Discussion**

It is decided to follow the same procedure for publication irrespective of the faculty. Preference to Citations can be given.

7. Any other points for discussion.

1. For Ph.D. in Management: Master in Business Administration / CA / ICWA with a minimum of 60% marks / CGPA 6.5 on a 10 point scale.

CA /ICWA are equivalent to M.Com.

MBA with CA should undergo course work with 12 credits.

M.Com with CA / CA direct should all undergo course work with 16 credits.

To proceed with the eligibility as per UGC norms.

2. Board of Research members advised to increase the number of full time candidates admitted for Ph.D programme.

Progress of Research Candidates – On Extension/ Break of Study/Cancellation of Ph.D
